It has moderate protein levels, and a good extract yield. Batch Number Format

Rahr Malting Co. uses a series of alphanumeric characters for malt lot codes. The first seven digits make up the Rahr reference number, associated with a bulk load. The next group of characters represent the Julian date, year, and production location. The final group of numbers represent the bag number.
